

Following the arrest of Comrade Gonzalo, 12 Sep. '92 Chairman of Peruvian Communist party, architect of the twelve year long peoples war - The Great leader of the proletariat, workers, peasants and the people of Peru: as a part of the foremanly declared programme of "Solidarity year" by "revolutionary Internationalist movement" - "Solidarity council to support the Peruvian peoples war Bangladesh" combined with many organisations brought out massive processions, meetings burning of U.S. flag as symbol of imperialist aggression, press conference etc. and took the statement of nine workers organisation, seventeen student leaders, nine political parties and twenty four renowned lady doctors, journalists, writers, University teachers and collected signatures in support of the release and defence of Chairman Gonzalo.

Just after that declaration and formation of International Emergency committee (IEC) arrived. Accordingly with those who demands the unconditional release and strongly oppose the sinister plan to kill comrade Gonzalo (Dr. Abemael Guzman) only as a communist revolutionary - "Committee to Release and save Dr. Abemael Guzman (Comrade Gonzalo), Bangladesh" similar to IEC formed in 11th Nov. '92. A starting committee with 29 member also formed to operate this committee of more than 100 members. The committee along with the previous declaration of IEC, continue the signature collection movement and sent separate faxes to U.S. backed Peruvian Fujimori Govt., the butcher and servant of Bourgeois class; and to Amnesty international to express deep hatred and protest. A vast programme also took including - a protest meeting and submission of memorandum at U.N human right commission in 19th Nov., regarding it a leaflet was also published: A poster demanding the unconditional release of comrade Gonzalo and opposing the Blue-print to kill him and Yankee aggression in Peru: A seminar and an open meeting, make funds with coupons and so on. These are in detail:

Signatures, as it were sent before- collections still now going on. At 10 a.m. 19th Nov., '92 - a meeting and procession held in front of National press club in Dhaka directed by joint convener Reazur Rahman and M. Nurunnabi as present, initiated by "Committee to Release and save Dr. Abemael Guzman (Comrade Gonzalo), Bangladesh". The persons who accompanied the meeting with their speeches are - Faiz Ahmed, president of combine cultural front and a renowned journalist; A.F.M Mahbul Haq convener of Bangladesh Samaitantrik Dal (Mahbul); One of the remarkable leader of Ganataitrik Biplobi Jote and famous leftist writer and intellectual - Badruddin Umar; Shibli Kaium of Biplobi Sramik Andolon; Mostofa Faruk of Bangladesh Samaitantrik Dal (Khalekuzzaman); Faizul Hakim of Bangladesh Krishak Federation; Samsuzzoha from Bangladesh Communist Union and Shahidullah of Bangladesh Chattra League. Following the meeting while a militant procession was approaching towards the U.N. co-ordinator's office in Bangladesh i.e U.N.D.P. Armed Riot - Police obstructed the way. In spite of that the procession marched forward and on submitting memorandum demanding the release of comrade Gonzalo and opposing the sinister killing plan of Fujimori regime by a representative team to U.N.D.P office - Deputy Resident Representative Uifqang Fisher received that on behalf of UN Human Rights commission.

Regarding to this programme: to organise, to move for struggle and to build up public opinion for demand of releasing and defending the life of Chairman Gonzalo and opposing the sinister blue-print - A leaflet was published and circulated by the starting committee.

After that, fund raising conducted with coupons by the committee aiming two points: 1) According to the call of IEC fund raising and sending for movements

in International era and 2) To afford similar type of movements in Bangladesh.

Considering the economic crisis of the proletariat and the people and some local speciality the committee decided for coupons of 2tk, 5tk, 20tk, 50tk, 100tk etc insted of donating one day wage for comrade Gonzalo the call of IEC. Furthermore some of Biplobi Sramik Andolon (R.S.M) and Biplobi Chattra Andolon (R.C.M) also donated their one day wage. The fund will be sent very soon. The cupon sums of Tk. 1,20,000/- in total.

As decided earlier - heading "Move Heaven and earth to defend and oppose the killing plan of comrade Gonzalo (Dr. Abmael Guzman), chairman of Peruvian Communist Party" - A bi-colour poster was brought out by the committee. The poster containing the protest slogans relevant to - U.S aggressin to suppress the people's war in peru, Brutal genocide by Bourgeois govt. and U.S. aggressin in the whole world with a T.V photo of hearing comrade Gonzalo in a iron-cage - are already spreaded in district towns, workers areas, slum areas and every where in the capital city which are still going on. It amounts 12,000 totally.

Except that of central programmes similar committee formed & observed various programmes all over the country . Some of them - In divisional town (Port city) Chittagong formed a committee to release & save comrade Gozalo which brought out a procession of more than hundreds on 27 December, '92 & hold a public meeting at centre of the town. Similar committee forneed in another divisional town (Industrial town) Khulna on 22 Nov. '92. It took various programmes including wall graffiti, fund rising postaring. In District town Mymensingh more than three hundred slum dwellers came down the street with patriot of Comrade Gonzalo demanding unconditional Release & protest the killing conspiracy of Comrade Gonzalo the militant procession moved around the town & hold a public meeting where the U.S. Flag was burned, postering, militant processions & demonstrations also observed in another district town Rangpur. In rural town Setabganqe formed a committee named "Movement to release & save Comrade Gonzalo" this committee hold a public meeting on 11 Dec., '92 & brought out several processions & published a leaflet with photograph of Comrade Gonzalo. In Remote District town Gaibandha, in support of the " com. to release & save Dr. Abimael Guzman (Comrade Gonzalo)" Bangladesh - Biplobi Sramik Andolon & Biplobi Chattra Andolon (Revolutionary workers movement & Revolutionary student movement) brought out militant processions & hold public meeting on 29, Nov., '92. Massive postaring similar programmes also observed in southern district town Barishal.

As the committee to Release and save Dr. Abmael Guzman (Comrade Gonzalo) Bangladesh decided for a seminar on the peoples war in peru and on the communist party of peru (PCP) in nearest future but at this moment the committee emphasises on fund raising and signature collecting.
